10. Root cut (damaged) plants with doubtful survivability rate shall be included in the supply lot.
11. Sick plants having any kind of disease shall not be supplied with the lot.
12. Plants carry bag should be of specified size and strong/robust material having sufficient earth in it.
13. Adequate precautions are to be exercised to prevent any damage to the plants while in transit.
14. In case of non-completion of Supply after the issue of supply order, dealers/firms will be debarred for bidding at IIT Mandi for the next one year.
