- Preference will be given to the experienced candidates.

#### For Specialist Doctor-

• Post-graduate diploma in an appropriate branch of Medicine plus at least one year experience in a recognized hospital.

OR

- MD, or MS, or DNB in an appropriate branch of Medicine/Surgery.
- Speciality like General Medicine, Pediatric and Obstetrics & Gynecology will be given preference. However other clinical specialists may also apply.

#### **Consolidated emoluments:**
