



WALK-IN INTERVIEWS

For the posts of Medical Officers (on contract) Purely Temporary

A walk-in interview is scheduled for two positions of Medical Officers (one male and one female) - **GDMO/Specialist Doctor** on **10.07.2024** at **09:00 AM** in **Conference Room, CV Raman Guest House, North Campus at IIT Mandi**. The posts are purely temporary and appointments would be initially for a period of one year and extendable, depending upon the need and performance. Desirous candidates should bring the original certificates along with self-attested copies of the same. Eligibility conditions etc. for the position are as under:

Qualification:

For Medical officer (Male/Female - GDMO)

- MBBS, including completion of compulsory rotating internship.
- Registered with Medical Council of India /State Medical Council.
- Preference will be given to the experienced candidates.

For Specialist Doctor-

- Post-graduate diploma in an appropriate branch of Medicine plus at least one year experience in a recognized hospital.
- OR
- MD, or MS, or DNB in an appropriate branch of Medicine/Surgery.
 - Speciality like General Medicine, Pediatric and Obstetrics & Gynecology will be given preference. However other clinical specialists may also apply.

Consolidated emoluments:

- Rs. 1,25,000/- to 2,00,000/- for Specialists Doctor per month.
- Up to Rs. 1,20,000/- (one lakh twenty thousand) per month for Medical Officer (GDMO) having minimum experience of five years in any recognized hospital
- Rs.60,000/- per month for fresher Medical Officer(GDMO).

Preferably below 65 years.
